## GENERAL

This membership agreement is subject to a 48-hour cooling off period. All members reserve the right to cancel their membership without giving cause or reason during the 48-hour period immediately after they enter into the membership agreement. Any requests for termination during the 48-hour cooling off period must be made to the Town of Cambridge in writing. Any membership fees will be refunded less the cost of any credit or vouchers used in that period.

Where a member loses their card, it is their responsibility to contact Wembley Golf Course immediately.

A \$10 fee for a replacement card is payable.

If the member is under 18 years old, a parent or guardian is required to complete the application and sign the declaration. Children aged 12 and under must be supervised on the Swing Driving Range at all times.

Members must comply with all Wembley Golf Course and Town of Cambridge rules and local laws (Rules and Local Laws)

All members use the Swing Driving Range and Wembley Golf Course at their own risk.
